BUIATRICS SUMMER SCHOOL – DAIRY CATTLE

UEVP (European Union Veterinary Practitioners) is happy to announce the 1st session of the Buiatrics Summer School – Dairy Cattle.

The BUIATRICS SUMMER SCHOOL – DAIRY COWS (BSS) is organised by Ordine dei Medici Veterinari della Provincia di Brescia (OMVBS) that is Brescia Province Veterinary Chamber and Fondazione Iniziative Zooprofilattiche e Zootecniche (FONDIZ) with the support of Federazione Nazionale Ordini Veterinari Italiani (FNOVI), the Italian Federation of Veterinary Chambers and UEVP.

1. The Buiatrics Summer School (BSS) is a full immersion experience in the dairy system: a unique training of 7 days with an overview on the principles of dairy farming and management.
2. The BSS will take place in Brescia, Italy.
3. The BSS will start July 5th 2026 and the duration will be 7 days, till July 12th 2026. From Sunday afternoon to Saturday evening. Sunday 12th will be devoted to departure.
4. The BSS will be held in English; therefore fluent English speaking is required.
5. The BSS will be open to 12 attendees.
6. The BSS attendance will be sustained by the Organization Committee (OMVBS, FONDIZ, FNOVI, UEVP) and will include food and lodging, the school attendance, farm visits and other activities organized by the BSS committee. Travelling to Brescia and back will be covered by participants.
7. Candidates need to be born in, or after, 1990, need to be a European Citizens, and coming from a country that is member of UEVP, hold a Veterinary Medicine degree, and be active practitioners in the buiatrics sector.
